New Business

a) CVAC News

Meeting with the CVAC board regarding funding. Interested in partnering on a fund raising event. They are motivated to distribute their funds. TD Bank supported CVAC for five years but has stopped this year, which suggests that they might be open to another arts organization's application for funding.

Gregg has just been elected as a Director on the CVAC board.

b) Finance and Communication

Emily shared a thank you note from Celeste Borjeau for a bursary. She reported that North Cowichan declined our application for funds and that the CVRD gave us \$8,000.00. Joyce will contact Dolores Wagg about a cancelled cheque. Emily reported that our 50/50 license had been mistakenly issued for two years, so we have to resubmit for 2016, but this does not affect our license for 2017.
